RESOLUTION TO AUTHORIZE PROFESSIONAL SERVICES FOR THE PLANNING
BOARD OF THE CITY OF SOUTH AMBOY

WHEREAS, the Planning Board (“the Board”) issued a Request for Proposals for Professional Legal Services to be provided to the Board; and

WHEREAS, the Board received one proposal submitted by Borrus, Goldin, Foley, Vignuolo, Hyman and Stahl, P.C. dated December, 2016; and

WHEREAS, the Board reviewed said proposal based on criteria outlined in the Request for Proposals and has determined that the firm of Borrus, Goldin, Foley, Vignuolo, Hyman and Stahl, P.C. 2875 U.S. Route One, North Brunswick, New Jersey, 08902 meets all criteria; and

WHEREAS, the Board has determined that the process utilized in selecting Borrus, Goldin, Foley, Vignuolo, Hyman and Stahl, P.C. meets the statutory requirements for award of a contract pursuant to the “Fair and Open” process of the Local Unit Pay-to-Play Law pursuant to N.J.S.A. 19:44A-20-4 et seq.; and




