RESOLUTION TO DISMISS APPLICATION FOR USE VARIANCE FOR BLOCK 116, LOT  
8 LANDS OF THE CITY OF SOUTH AMBOY

WHEREAS, application has been made by Christ Church, ("Applicant") to the Planning Board of the City of South Amboy ("Board") for a use variance (Block 116, Lot 8 located in South Amboy) to permit certain additional charitable activities to be conducted on the property; and

WHEREAS, the Planning Board originally scheduled a public hearing on September 27, 2011, which was subsequently canceled due to insufficient notice being provided by the Applicant; and

WHEREAS, the Applicant thereafter requested several extensions of time in which to proceed with the Application; and

WHEREAS, the Applicant has failed to provide sufficient notice to the public in order to conduct a meeting on the Application; and

WHEREAS, on or about March 2, 2012, counsel for the Board sent a letter to the Applicant requesting that the Applicant either appear before the Board or make its intentions known or the Board would dismiss the Application for failure to prosecute same; and

WHEREAS, the Applicant failed to respond to the March 2, 2012 letter from the Board's counsel.



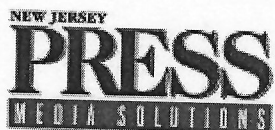
